Successful proposals will promote curatorial perspectives fostering critical dialogue and artistic exploration through local and/or global engagement. Proposals are evaluated in January and June annually.

EXHIBITION OPPORTUNITY:

- Beautiful 6,300 square feet exhibition space in the Santa Ana Artists Village.
- Curator honorarium of \$500. Applications for grants to augment honorarium are encouraged.
- Support with installation, de-installation, signage, publicity, marketing, programing, gallery supervision, and opening reception during Santa Ana's monthly First Saturday ArtWalk.
- Three-week exhibition run plus a five-day installation period; One-day de-installation period. •

GUIDELINES:

- Curators will be responsible for exhibition curation including Curator's Statement, coordination of art deliveries and installation, artists, opening reception planning, any programming, and coordination of exhibit deinstallation planning.
- Travel, shipping, transport budget and art crate storage are not available. Local-area sourced artworks • are encouraged.
- Proposals may be submitted at any time. Proposals will be evaluated every January and June. •

Incomplete applications will not be considered.

- If special equipment is needed for installation, briefly describe.

2) CURATORIAL NARRATIVE: Describe the purpose, themes, artists, works to be included and relevance. This narrative is limited to a maximum three-page (3) document (word or pdf). More than three (3) pages will not be read.

3) LABELED IMAGES representative of the proposal need to be consolidated into a single document_via pdf. word doc. or PowerPoint file.

Individual image file attachments will not be considered.

4) CURATORIAL/ARTISTIC EXPERIENCE AND RESUME: brief statement outlining your curatorial and/or artistic experience, curatorial approach/practice, achievements, or other upcoming curatorial projects. Additional images or web links that show past curatorial work is encouraged. Resumes of proposed artists to be exhibited or other significant contributors may be included. All information must be consolidated into a single document, word, pdf, or PowerPoint).
